#### ENABLING UNIT, HANSRAJ COLLEGE, DU

An Enabling Unit was formed in the college on 23rd October 2011. Prof. UmeshRai (Director, South Campus, University of Delhi) and the College Chairman, Padma Shri Dr. S.K. Sama had graced the occasion and had an interaction with the students of this unit. This cell consists of more than 100 volunteers to assist students with physical disabilities, with their regular course of studies. This society acts as a bridge between college administration and the differently abled students. This society also organizes various seminars and awareness campaigns, as well as an Annual Cultural Fest i.e. Pahal. A positive and healthy relation is promoted between the differently abled students and the larger student community in college.

Since 2013, laptops have been distributed to every differently abled student in the college as an assistive device. A recording device, Angel, is provided to the visually challenged students to record their lectures. Earlier iPods were distributed to the differently abled students by the cell. Braille books are provided to read, and Braille slates and chalks to write. Scanners and printers along with five computer systems are made available in the Enabling Unit Room. A separate reading/writing room has been provided since 2014. Magazines and Journals in Braille form are purchased monthly. The institution also has the provision of wheelchair.



HANSRAJ COLLEGE. DU

The College was founded by the D.A.V. College Managing Committee on July 26, 1948 in the sacred memory of Mahatma Hansraj, a pioneer in the field of education. It is today one of the leading lights in the D.A.V. family of over 700 institutions and one of the largest constituent Colleges of Delhi University. 


#### CENTRE FOR DISABILITY STUDIES, GUJARAT NATIONAL LAW UNIVERSITY.



Mr. Anant Kishore Saran

Shri Anant Kishore Saran Currently Director of Police MHA, PS to MoS for Home, Former Director Ministry of Shiping Govt. of India. Shri Anant Kishore Saran is a CSS Officer of 1996 batch. He has worked at various key positions in the Department of Telecommunication, Ministry of Communication & IT and Ministry of Youth Affairs & Sports. He was working in Ministry of Shipping and was responsible for Port Development projects in India including the PPP projects and dredging projects in Major Ports. He has been instrumental in award of record number of Port augmentation projects during the last two years and has streamlined security clearance of bidders for port projects. He was also the Board Trustee of Cochin Port Trust and Tuticorin Port Trust and on the Governing Board of the Indian Ports Association. Apart from the policy initiatives in port development, he was associated with the prestigious "Sagarmala Project". He was earlier involved in several policy initiatives of the Ministry of Shipping including the replacement of the Major Port Trusts Act, 1963 by "The Major Ports Authority Bill". He is an disability rights activist as well as interested in disability studies. He has been at the centre of the disabled student's movement, which took place in the year 2012 at university of Delhi. He has also been writing various short articles on different aspects of the lives of disabled persons.Currently, he is working as PGT POL.SC. at GBSSS, DHAKKA school of dept. of education, NCT OF DELHI.

Until she was seven, Mrs.Rath could read in sunlight or in a well-lit room. But as the disease progressed, it became impossible for her to read or recognize faces, making her one of over 2.3 million visually impaired women in India. Manjula Rath was eight years old, the eldest among her siblings, when her father decided to leave.

"Looking at four blind children every day and knowing he couldn't do anything about it, he was sure we had no future," she says matter-of-factly.

Because Rath and her siblings could see a little in the beginning, there seemed some hope of recovery. But with their vision deteriorating over time, it was clear they would never be able to see. All four, three girls and a boy, have retinitis pigmentosa, a rare, genetic disorder that gradually breaks down cells in the light-sensitive tissue lining the back of the eye, known as retina. Manjula Rath always dreamt of becoming a university professor, but it was only in 2008 that she applied and got a job in "University of Delhi"

Mr. Dhananjay Bhole


